Internal Affairs

This guide is intended to help citizens who wish to file a complaint of alleged misconduct by an employee of the Monroe County Sheriff's Office. If, after reading the following information, you have a question about Internal Affairs, or about making a complaint, you may contact any of the offices listed below, or email Captain Don Hiller at dhiller@keysso.net.

Types of Investigations

The Sheriff's Office has two types of investigations of employee misconduct; Supervisory Reviews and Internal Affairs investigations. An Internal Affairs investigation is conducted when the allegation is criminal misconduct, corruption, brutality, or breach of civil rights. The Internal Affairs Division will also investigate other complaints as directed by the Sheriff.

What to expect during the investigation

After making the complaint, either by phone, mail or in person, the supervisor or inspector will tell you who specifically will be conducting the investigation and what case number it has been assigned. The investigator will also explain to you how to keep in touch with them during the investigation. You may feel free to contact the investigator at any time to inquire about the investigation.

When it is concluded

Complainants will receive a written notice with the findings of the investigation. A copy of the entire investigation may be obtained upon request with no cost to the complainant.

Complainant Obligations

While the Monroe County Sheriff's Office can and will accept anonymous complaints, we will ask at times for sworn, recorded testimony. This is not done to discourage complaints, but rather to protect the complainant and ensure that the complaint is investigated to the fullest. We also request that complainants do not discuss the complaint or any information provided by the investigating officer during the investigation stage of the complaint. This, of course, does not apply to discussions between attorneys and their clients.

The complainant should always be aware that filing a false complaint could result in perjury charges being filed against them.
